2020 Lucky's on the Lake and Lake Wisconsin Alliance 6th Annual Ice Fishing Tournament Rules

Listed below are the contest rules for the 2020 Ice Fishing Tournament. Rules may be subject to change. All decisions by Tournament Officials are final.

1. Fish eligible for the Ice Fishing Tournament **must be caught on Lake Wisconsin, WI** during the contest hours of 6:30AM - 3:00PM on Saturday - February 8, 2020.
2. Participants registering the day-of the event (6:30 - 7:00 AM at Lucky's) may not register any fish caught prior to registration for the event.
3. All participants registering fish must be back and checked in by **3:30 PM**.
4. Winning fish of each species will be determined by length measured to the nearest 1/8 inch for each entrant registering fish. Entrants may register 1 legal fish per species, while observing legal limits **AND** tournament minimum lengths, regardless of species. **100% total payout**. Cash prize value will be based on the number of entrants according to the payout schedule below. If a species or category is not caught, the prize pot for that species or category will re-distribute to biggest fish prize for the species or categories that were caught.

1/6th Biggest Walleye/Sauger

1/6th Biggest Bluegill/Sunfish Species

1/6th Biggest Crappie

1/6th Biggest Perch

1/6th Biggest Northern Pike

1/6th Biggest Bass (White/Striped/Yellow/Largemouth/Smallmouth)

5. Minimum lengths to register by species for the tournament are as follows:
Perch – 7" minimum
Bluegill or Sunfish – 6" minimum
Walleye or Sauger -15" minimum (**20" - 28" SLOT LIMIT IS IN EFFECT**)
Northern Pike – 26" minimum
White/Striped/Yellow Bass – 9" minimum
Crappie - 9" minimum
Largemouth and Smallmouth bass – 14" minimum
